Document Checklist

DOCUMENT

Unless “original” is specified, provide only a photocopy or printout of the items on this list.

****Any document in foreign language submitted with your application must be accompanied by a certified English translation.**

Proof of identity (provide all the following):

- ☐ Two original 2-inch-by-2-inch passport-style photos (print your full name and Alien Registration Number (A-Number) on the back of each with a pencil or felt-tip pen)
- ☐ Front and back of Permanent Resident Card (green card)
- ☐ Non-U.S. passport (photo page only)
- ☐ Any other government-issued photo ID
- ☐ Non-utility bills: phone, gym membership, credit cards, etc.
- ☐ Updated birth certificate (if the one you originally submitted with your green card application has been updated)

Residential-history record (provide the following)

- ☐ Original list of all addresses where you’ve lived since filing your green card application, or “Adjustment of Status,” including start and end dates for each

Proof of “bona fide” (authentic) marriage (provide the following)

- ☐ Marriage certificate (with certified English translation, if the original is written in a language other than English)

In addition, provide as many of the following as possible:

- ☐ Photos of your life as a couple
- ☐ Any other proof of a “bona fide” marriage: receipts for wedding rings or gifts you purchased for each other, wedding invitation, etc.

- ☐ Activities as a couple with both your names noted: Hotel receipts, Airline tickets, boarding passes, Timeshares, etc.

Joint financial records (showing both spouses’ names) since filing your green card application, or “Adjustment of Status” (provide as many of the following as possible):

- ☐ Insurance policies: life, health, dental, auto, renters, homeowners, etc.
- ☐ Bank accounts: monthly statements, account-opening letter(s), etc.
- ☐ Utility bills: electricity, water, gas, sewage, garbage, cable, internet, etc.
- ☐ Non-utility bills: phone, gym membership, credit cards, etc.
- ☐ Housing: mortgage, rental lease agreement, etc.
- ☐ Income taxes: federal income tax returns from the two most recent filing years

Contact records (provide as many of the following as possible):

- ☐ Records of travels together: flight confirmations, plane tickets, itineraries, hotel bills, etc.
- ☐ Email exchanges
- ☐ Phone (call) logs
- ☐ Text messages you sent to each other
- ☐ Social media messages you sent to each other
- ☐ Letters or cards you wrote to each other

Children’s records, if you have a child or children together, whether biological or adopted (provide the following for each child):

- ☐ Birth certificate (with certified English translation, if the original is written in a language other than English)
